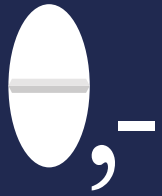
Amgros -since 1990

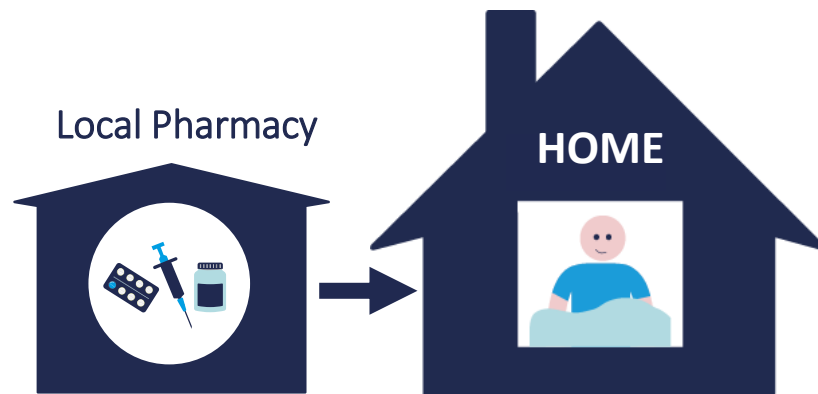

THE DANISH SET UP

PRIMARY CARE

General practitioner & municipalities

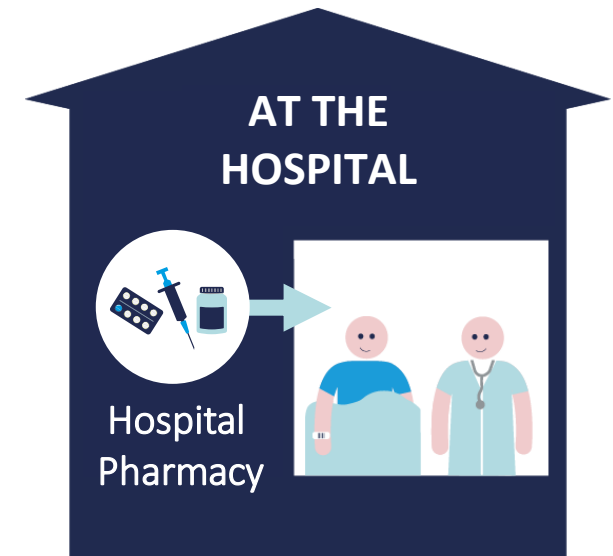
- Reimbursement (needs-based and automatically calculated at the pharmacy)
- Pricing: 14-day auctions.



SECONDARY CARE

Inpatient & outpatients

- Medicine handed out is free of charge.
- Tenders by the regional purchasing organisation (Amgros).



SUSTAINABLE DEVELOPMENT GOALS CALLS FOR INVESTMENT – FROM US ALL

- Amgros' role is a central player in the Danish Healthcare system with responsibility for procurement of medicines and hearing aids to the public hospitals and hearing clinics in Denmark
- Procurement must be carried out in a sustainable way to aim for reducing the effects on the environment
- Procurers have buying power to impact the green agenda

AMGROS LAUNCHED IN PRIMO 2021 A TENDER INCLUDING ENVIRONMENTAL CRITERIA

Nationale tenders

- The tender was asking for submission of hormones (ATC-kode G & H)
- Sustainability criteria on the packaging (plastic & paper & carton) & transportation
- New contract requirements to suppliers sustainable production and environmental management agenda

Joint Nordic Procurement

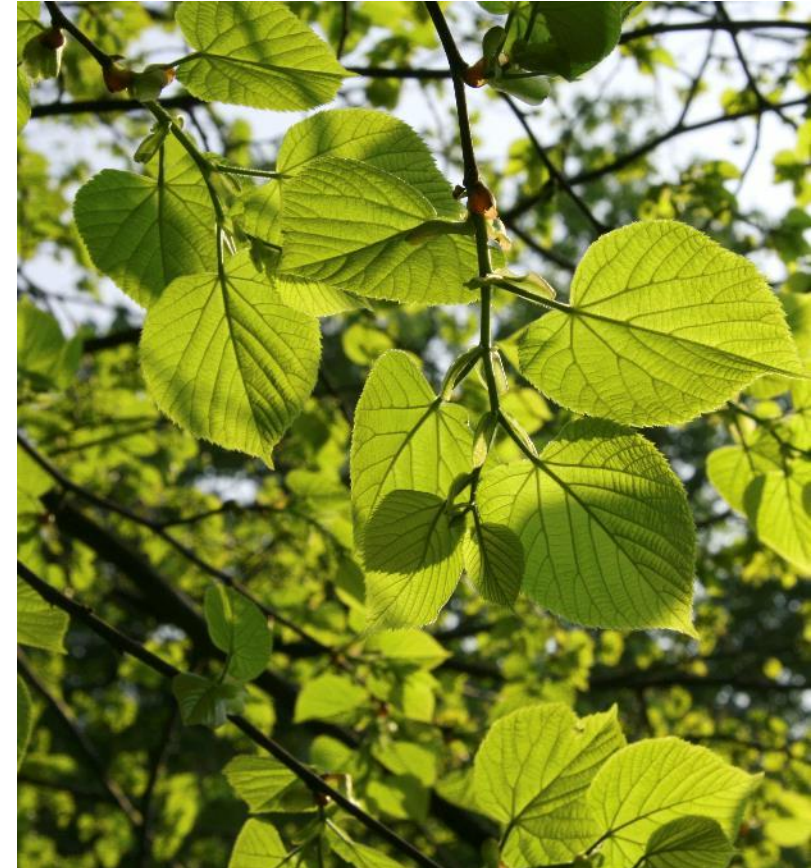
- In collaboration w/ NO & ICL , Amgros conducted second joint Nordic tender on pharmaceuticals- this time with environmental criterias
- A documentation needed to certify environmental management, environment policy and sustainable transport was expected



LEARNINGS: STRONG SUPPORT TO FIRST NATIONAL TENDER WITH ENVIRONMENTAL CRITERIA

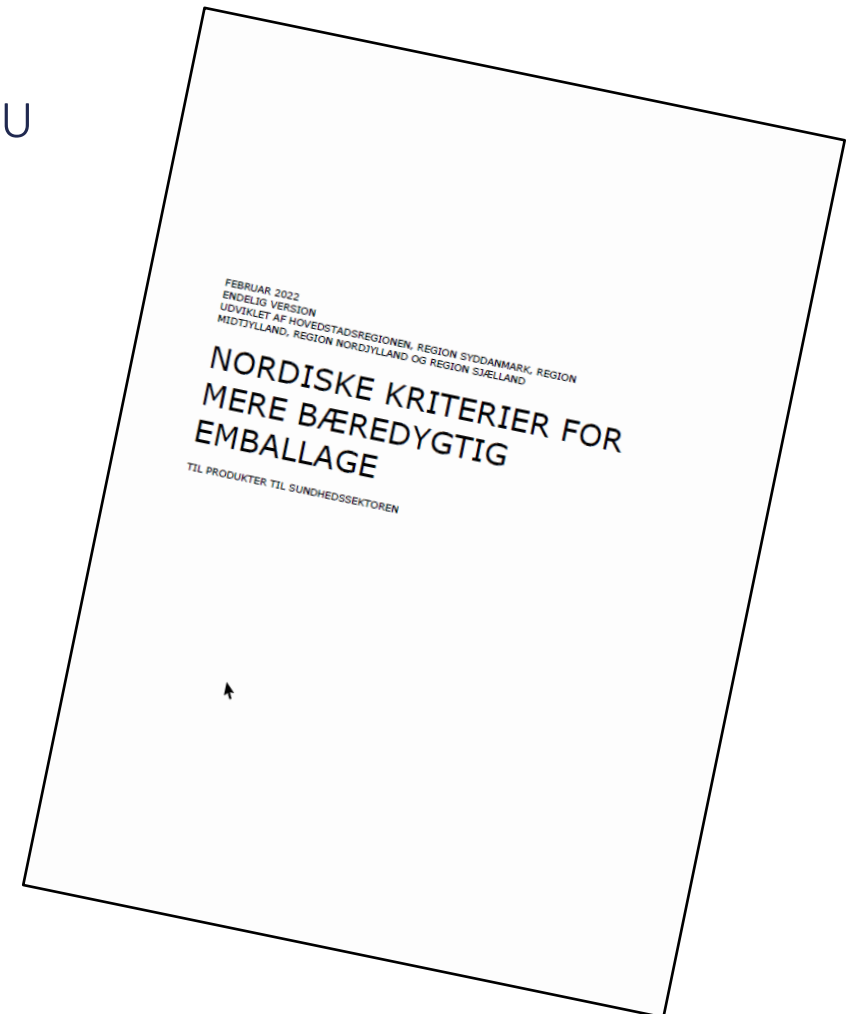
- September 2021: First national tender with sustainability criteria
- Result: 85 offers. Number similar to previous years tender submissions
- Focus on ATC-code G and H (Hormones)
- Suppliers have been supportive and part of the definition of the actual criterias

NEXT STEP IS THE PACKAGING

- Suppliers are already asking for joint criterias across Nordics or EU
- *A brief on "Nordiske kriterier for mere bæredygtig emballage"*
- Purpose is to
 - Reduce amount of packaging
 - Increase repurpose of the packaging
 - Increase share of reused material and biobased packaging
- Not all criteria fit to pharmaceutical procurement



CHALLENGE PUT FORWARD TO US - AND OUR PARTNERS

- Expectation in procurement and supply of medicines and hearing aids will be a more sustainable approach – from us all.
- A balance is needed to secure environment and the security of supply in Denmark.
- Sustainable development is not a single responsibility.
- Amgros expects a joint partnership with our collaboration partners and with our network relations in other countries.
